HOW TO EXERCISE THE RIGHT OF WITHDRAWAL

In accordance with applicable law and the Conditions of Sale accepted by you at the time of purchase, the exercise of the right of withdrawal is subject to the following conditions:

- 1) Within 14 (fourteen) days after receiving the product in question, this form must be e-mailed properly filled in to support@vr46.com. If the Products have been sent by the Seller, the Seller will e-mail the "Return Code".
- 2) Within the same period of 14 (fourteen) days after the receipt of the "Return Code", it is necessary to write down in this form the "Return Code" and deliver the return product(s), together with this complete form of "Return Code", to TRIBOO DIGITALE S.r.l., at:

and to the carrier in charge of the return.

If multiple products are returned, they must be returned to TRIBOO DIGITAL S.r.l. at the same time and/or with the same shipment. It is also necessary that:

- (a) the product is intact;
- b) all tags and labels are unaffected and still attached to the product;
- c) the product is returned in its original packaging;
- d) the return is accompanied by the form in step 1, complete with "Return Code".

In view of the legitimate exercise of the right of withdrawal, TRIBOO DIGITAL S.r.l. will reimburse you the price of the returned product, including the cost of the first shipment, within 14 (fourteen) days from the date on which it became aware of the exercise of that right.

EXCLUSION OF THE RIGHT OF WITHDRAWAL

We inform you that in accordance with art. 59, first paragraph, point (c) of D. Legislative Decree n. 206/2005 (Consumer Code), the right of withdrawal is excluded with regard to the supply of "tailor-made or clearly personalized products". With reference to the above-mentioned case of exclusion of the right of withdrawal, you are informed and you accept that in the "tailor-made or clearly personalized products" the Products indicated as customizable in the relevant information sheet are included.
